In addition, this position will assist with the collection, review, and reporting of key performance indicator data associated with their work in these areas.

- Bachelor's degree in Analytical Chemistry, Biochemistry, Microbiology, Biology, or related science required.
- ISO, SQF and/or FSSC 22000 knowledge. Ideal candidate will have experience building, deploying, and managing GFSI systems as well as adapting SQF to Purified Bioethanol, and Bioethanol fuel specific requirements.
- HACCP Certification and SQF Practitioner Certification preferred.
- Experience in managing SQF systems and other third party audit/customer requirements.
- Preventive Controls Qualified Individual (PCQI) lead instructor certification a plus.
- Experience in process optimization such as TPM or Lean Manufacturing to facilitate program roll-out and benchmarking.
- Ability to work in fast-paced environment while meeting multiple deadlines.
- This person must be self-motivated and have the ability to work with little supervision.
- Proficiency in Process Information (PI) and Statistical Process Control (SPC) software is a plus but notrequired.
- Knowledge in Microsoft Office Suite and the ability and willingness to learn new software applications.

- SQF, cGMP, HACCP, FSSC 22000, ISO and other third party program oversight as applicable to Purified Bioethanol, Bioethanol Fuel, and CO2.
- Owner of Purified Bioethanol, Bioethanol Fuel, and/or CO2 supplier verification documentation and primary point of contact for customer inquiries
- Work closely with the POET Bioprocessing Quality Control team to ensure adequacy of the quality system.
- Work closely with the POET Bioprocessing Team to implement any new provisions required by customers, third party certification bodies, and/or government agencies.
- Perform all tasks associated with product safety and quality, assigned or as needed, to meet internal and external requirements relating to the delivery of safe, quality products.
- Manage a system of key performance indicators to show continued improvement at the bioprocessing facilities regarding compliance.
- Delegate responsibility and expect accountability among team members by fostering a spirit of teamwork.
- Assist POET Bioprocessing facilities through troubleshooting and on-site training.
- Work in an honest and ethical manner; maintain confidentiality on all business-related matters.
- Foster a culture of safe behavior and environmental compliance at all times.
- Maintain a team environment, driven by a customer service focus, at all times and champion POET in the community.
- Other duties as assigned.
